Casa Grande, Arizona, April 18, 2014— First American Credit Union has partnered with COOPERA (ko-pair-a) to offer a prepaid Visa debit card that can be used to make purchases online, by phone, or in person anywhere Visa debit cards are accepted.

Created to help credit unions meet the financial needs of consumer segments including Hispanics, the underbanked and teens, the Coopera Card is the result of a partnership between the payments processing company The Members Group (TMG) and Hispanic market solutions firm Coopera. The Coopera Card offers a completely bilingual experience in English and Spanish, as well as text alerts, secondary cards and online account access.

With no risk of overspending, no overdraft fees, and no interest fees, consumers can conveniently load money at the credit union or online. And better yet, primary cardholders can add up to six secondary accounts for family members.

The card, tailored by COOPERA for the Hispanic audience, is easy to open with no credit history check, no SSN or ITN, and no financial institution account being required.
